The Courts Phase will be included in this phase instead of waiting to interrupt the GRT Phase to avoid bothering staff when they move in. Staff should be in by October or September. The design phase for the Courts is complete. Manager Martinez stated Mr. Leslie has full control of the site, he documents everything that takes place. As soon as the GRT Phase is completed the construction for the Courts Phase will begin upstairs. Everything is moving forward.


