RESOLUTION NO. 17-33

A RESOLUTION AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE MORA COUNTY MANAGER TO ACT AS THE MORA COUNTY CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO MORA COUNTY'S PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within *MORA COUNTY* for neighborhood improvement projects in several low and moderate income neighborhoods, and *MORA COUNTY* desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for neighborhood improvement projects; and

WHEREAS, *MORA COUNTY* has held one (1) public hearing for public input and comment during the 2017 application process; and

WHEREAS, the *MORA COUNTY COMMISSION* finds that there is a significant need to undertake the *WATROUS COMMUNITY CENTER* to provide adequate services to the community; and

WHEREAS, the *MORA COUNTY COMMISSION* determines that the *WATROUS COMMUNITY CENTER* meets the requirements of the Community Development Block Grant Program.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF MORA, NEW MEXICO, that

1. *MORA COUNTY* is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for the *WATROUS COMMUNITY CENTER*.

2. That the **MORA COUNTY COMMISSION** directs and designates the **MORA COUNTY MANAGER** as **MORA COUNTY'S** Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and **MORA COUNTY'S** participation in the New Mexico Community Development Block Grant Program;

3. **MORA COUNTY** officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution;

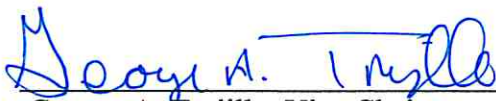
4. That the full application amount be for **\$500,000** and phased application amount be for **\$450,000** of grant funds to carry out **WATROUS COMMUNITY CENTER**;

5. That it further be stated that **MORA COUNTY COMMISSION** is committing **\$25,000** from its **General Fund** as a cash contribution toward the **COMPLETION** of the **WATROUS COMMUNITY CENTER**.
