Finance Director Ms. Sena stated that this resolution is to authorize the withdrawal of the interest from the SB6 Loan to fund the project four positions that have been contracted to work on the category b projects in the amount of \$144,185.82. Attorney Ms. Cruz stated this item should be tabled until the proper language be done to see if the amount should be taken out from one of loans or should be taken out from all four loans to insure the positions wouldn't have to be bided out again. More discussion was had, Attorney Ms. Cruz recommends this item be tabled until a revised resolution reflect that a 25% amount be taken from each loan to cover the positions in the amount \$35,296.31, until after the change be done.
