# MORA COUNTY BOARD OF COMMISSION Special Meeting November 20, 2023

### 1. CALL TO ORDER:

Commissioner George Trujillo called the meeting to order at 4:37 p.m.

### 2. PLEDGE OF ALLEGIANCE AND SALUTE TO THE FLAG OF THE STATE OF NEW MEXICO:

County Attorney Ms. Cruz stated that this resolution to withdrawal the SBA loan funds from the LGIP account but would like for the Finance Director to explain the amount and any other questions the board may have. She recommends that the Board table this until the next meeting.
