## ITB No. 2024 Invitation to Bid for Propane for Volunteer Fire Departments

1. <u>SPECIFICATIONS:</u> The County of Mora Fire Services require heated facilities to house its firefighting apparatus and equipment. Therefore, the County of Mora (hereafter "the County") seeks bids from qualified vendors for the following propane services at all Mora County fire stations: (1) supply propane to all listed fire stations and sites, and (2) provide gas appliance maintenance and repair service (on an emergency basis when required) to all fire stations and locations.

- 2. <u>PROVISION OF PROPANE</u>: The contractor shall keep all propane tanks filled throughout the four seasons of the contract term.
- 3. <u>FUEL PRICING:</u> Vendor shall submit the total set price per gallon for propane to be delivered. This price is inclusive of all overhead costs and delivery. Bids are to be submitted for, total set price per gallon delivered. The price should be firm for one year.
- 4. <u>APPLIANCE MAINTENANCE</u>: Vendor shall provide a quote the cost associated with gas appliance maintenance and repair service (on an emergency basis when required).
- 5. <u>SERVICE TERM:</u> The initial term of the proposed contract shall be from the contract execution date for a period of one (1) year; with possible renewal every year for up to three

- years subject to County Commission approval. (Section 13-1-150 NMSA.) The bid award and initial contract must be approved by the Mora County Commission.
- 6. <u>APPROPRIATIONS:</u> The County reserves the right to cancel the contract at any time, for any reason, without penalty, by giving at least thirty (30) days written notice to the successful vendor. Written notice shall be deemed delivered when deposited in the United States Mail and certified. In addition, any contract awarded as a result of the Invitation to Bid may be terminated if insufficient appropriations or authorizations exist.
- 7. <u>LICENSING</u>: The Vendor awarded the contract shall possess a current business license, in the State of New Mexico, and a business license in Mora County and shall obtain and hold such additional licenses as are reasonably required to accomplish his or her duties under this Agreement.
- 8. <u>TAXES</u>: The Vendor awarded the Contract shall be responsible for the payment of all federal, state, local taxes on monies received pursuant to any contract award.
- 9. <u>ASSIGNMENT:</u> A Vendor shall not transfer, sell, assign, sublicense, pledge or otherwise dispose of in any way its interest in any contract, without having first obtained the prior written consent of the County to do so. Any attempt by a Vendor to do any of the foregoing without such consent shall be null and void and may result in disqualification of the Vendor or termination of any contract resulting from this solicitation. The County's consent to any of its duties to perform all agreements, covenants, and conditions set forth in this solicitation or any resulting contract.
- 10. <u>IDENTITY OF THE VENDOR:</u> Each Bid shall identify the company submitting the bid and shall further identify its organizational structure (e.g., sole proprietorship, corporation, etc.), whether the company is authorized to do business in the State of New Mexico, where the organization is based, where its principal place of business is located and, if a corporation, where it is incorporated.
- 11. <u>BINDING THE VENDOR</u>: Each Bid shall identify, by title and/or position, the person authorized by the organization to enter a Contract with the County. That person shall sign the bid. The Bid shall bind the organization to complete the work described in the Bid.
- 12. <u>CONTACT PERSON:</u> Each Bid shall identify the names, titles, and telephone numbers of person whom the County may contact for clarification or for further information.
- 13. <u>RESPONSE TO SPECIFICATIONS:</u> Each Bid shall provide a written response to each specification requirement. If an Offeror is unable to provide an item, which is required by the specifications, it shall take written exception to the specification.

- 14. <u>ACCEPTANCE OF TERMS:</u> Each Bid shall explicitly indicate the business acceptance of the additional terms and conditions set forth in this Invitation to Bid. If the organization proposes alternative terms and conditions, it shall identify them in the bid.
- 15. BID OF OFFEOR: Each Offeror shall submit a completed Bid Form.
- 16. <u>CANCELLATION OF THE INVITATION TO BID:</u> The County reserves the right to cancel this Invitation to Bids at any time, and to reject any or all bids in whole or in part, or otherwise proceed in the best interests of the County. This Invitation to Bid in no manner obliges the County or any of its agencies to the eventual purchase of any product or service, whether explicitly described or implied herein, until confirmed by a written contract and/or Purchase Order.
- 17. <u>PROHIBITED CONTACT WITH COUNTY EMPLOYEES:</u> Vendors are specifically notified that any attempt to contact any person in the County of Mora other than the party listed herein concerning this procurement, shall be caused to reject said Vendor from further consideration.
- 18. <u>QUALIFICATIONS</u>: The Vendor shall be experienced in, knowledgeable, and fully capable of providing the propane and providing emergency maintenance of gas appliances as required under this bid.
