County Attorney Cruz stated that this claim will cover the additional employees the county will need in the future to ensure it can provide services for the community. Such as additional employees for the Assessor's office (2), Clerk's office (2), Sheriff deputies (3-4), Treasurer's office (1) Manager's staff (3), Solid waste (3) Road Dept. (3) EMS (3-4), Finance Dept. (2) P&Z (2) Reception (2) and other not mentioned. She recommends the Board to approve as presented.

19. DISCUSSION/ACTION – IDENTIFICATION OF FIRST SET OF PRIORITIES FOR ROADS CONSTRUCTION FOR PROCESSING BY THOMPSON CONSULTING:

County Attorney Cruz stated that this item covers the priority roads to be done by Thompson Consulting. She stated that the H&H study done was not correct and according to Thompson Consulting their H&H study shows difference in different areas such as culverts and drainage and road measurements. She went over the area where Singleton Schrieber could assist Thompson with the SB6 monies.

Michael and Christina stated that they need the Board to prioritize the roads they want worked on as soon as possible. Michael stated that Attorney Cruz is correct the H&H study was totally off, and this will affect the amount of monies needed for each project, example what cost \$3 million may go up to \$10 million. He and his staff walked some roads to find the number of culverts needed is incorrect. Most need more than just two culverts: some

need up to 22 culverts, and the drainage is non-existent in other areas. More discussion was had on the needs of specific roads. He requested the Board's list of priority roads they want worked on as soon as possible.

The Board listed A-004, B-019A, B-019, B-028, B-028A, A-001, A-006, A-005, and A-042. As the top 9 roads they want done.

Attorney Cruz recommends the Board approve the set roads as decided.
